#### **Commission Committee Reports**

Deb Loseke presented the draft of County Improvement Fund Grant Application created by the Best Practices Committee. Tony Moody motioned to approve the draft. Mike Kesselring added an addendum to the motion, to include the wording "as referenced in the Nebraska Tourism Commission Strategic Plan." John Chapo seconded the motion. Motion carried. The grant application created by the Best Practices Committee will be promoted at the NACO conference in December.

Mike Kesselring noted he would like to serve on a sub-committee regarding the development of a new model for evaluating the value and performance of Nebraska Tourism. Roger Kuhn and Mitch Glidden will also be on the sub-committee. Some research will be done by this sub-committee, to define tourism and the measurements of tourism's economic impact. The sub-committee hopes to research over the winter months, and present findings to the group in 2014 meetings.

Jeff Boeka welcomed Rich Claussen of Bailey Lauerman to the meeting. Rich Claussen noted Bailey Lauerman is holding focus groups to produce the new Nebraska tourism brand. Resident and non-resident surveys are available, as well as surveys for stakeholders. The marketing plan will be released in spring of 2014, to follow upcoming PR strategies and brand development.

# Financial Update

Kathy noted that additional PSL has been requested for the Nebraska Tourism Commission, in hopes of attaining four additional full time staff members (IT, research, marketing manager and field staff). The request will be sent through the legislative process, approval or denial won't be known until 2014 legislative session. John Chapo motioned to approve the deficit request issue for 2014.
